TERMS AND CONDITIONS OF THE LAUS & DELTA WINES SPRING-SUMMER 2023 CAMPAIGN

BODEGAS LAUS, S.L., hereinafter LAUS, with registered offices at Ctra. N-240, Km 154, 22300, Barbastro (Huesca), VAT number B-22257653, will carry out a sales campaign in the Netherlands, to promote LAUS products, and will be in charge of the raffle organisation, as well as of communicating and delivering the prizes to DGS Wijn for their distribution. The campaign will be governed by the following terms and conditions:

1. Participation criteria.

- Any customer that has purchased a LAUS wine in the participating establishments, is of legal age and complies with the requirements established in these terms and conditions may participate in the raffle.

2. Advertisement of the campaign.

- The campaign will be publicised to consumers by means of promotional posters in participating establishments.

3. Duration of the campaign.

- The campaign will be valid from the 1st of July of 2023 until end of stock and is bound by the published terms and conditions. Should it be necessary to postpone, modify, cancel, or repeat the campaign due to unforeseen circumstances, LAUS will be responsible for notifying it.

4. Prizes.

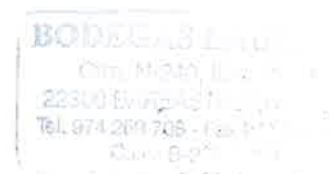
- Each participating establishment will receive a set of 100 participation tickets, among which there will be 10 prizes, depending on the combination of each kit:

- o 1 organic cotton sandwich pouch
- o 1 recycled cotton vanity bag - beige
- o 1 recycled cotton vanity bag - green
- o 1 recycled cotton vanity bag - red
- o 3 100% cotton LAUS tote bags
- o 1 LAUS thermo bottle
- o 2 LAUS hats

- All these prizes are not exchangeable for either cash or other prizes.

5. Campaign details

- For the purchase of any LAUS wine, throughout the campaign and in participating establishments, customers will receive a raffle ticket that they will have to scan to find out if they are in possession of a winning ticket.



6. Acknowledgement of the terms and conditions

- The following terms and conditions will be published on the LAUS website, which customers can access by means of the QR code provided by participating establishments. Said terms and conditions will also be deposited at the central offices of the COMPANY, located at Ctra. N-240. Km 154, 22300 Barbastro (Huesca). By entering the raffle, participants fully and completely accept these terms and conditions. In the event of possible doubts in the interpretation of these terms and conditions, the Organiser's criteria will prevail.

7. Disqualification

- LAUS reserves the right to exclude those participants who make fraudulent use of the tickets. LAUS reserves the right to eliminate and/or withhold the participation of any user who defrauds, alters, or disrupts the proper functioning and regulatory course of this campaign. LAUS intends that all users compete on equal terms in each of its campaigns, with strict respect for the rules. Therefore, any abusive or fraudulent use of the terms and conditions will lead to the disqualification from the raffle.

8. Other remarks

- The prizes will not be exchangeable, alterable, or eligible for compensation upon demand. The prizes won in the raffle are non-transferable, that is to say, in the event that the winner is unable or unwilling to accept the prize, it will be declared void.

9. Taxation liability

-In order to withdraw the prize, that established in the current Personal Income Tax Regulations, approved by Royal Decree 1841/91 of the 30th of December 1991, and other related regulations will be applied. By accepting the prize, the winner will assume all expenses incurred, except those expressly covered by the campaign, as well as any liability that may arise from the collection and use of said prize. As such, the winner will be responsible for all the taxes or expenses that are not specifically mentioned in these terms and conditions.
